# THE ELECTRICITY WORKS (ENVIRONMENTAL IMPACT ASSESSMENT) (SCOTLAND) REGULATIONS 2017

Notice is hereby given that Renewable Energy Systems Ltd (RES), company registration number 1589961, with its Registered Office at Beaufort Court, Egg Farm Lane, Kings Langley, Hertfordshire, WD4 8LR, has applied to the Scottish Ministers for consent under section 36 of the Electricity Act 1989 to construct and operate a generating station comprising of a wind farm and battery energy storage system, known as Sclenteuch Wind Farm, in both South Ayrshire and East Ayrshire near Waterside, west of the A713 (Central Grid Reference 240700E, 607500N). The combined installed capacity of the proposed generating station would be 99 MW (54 MW wind farm and 45 MW battery energy storage system) comprising up to nine turbines with a maximum ground to blade tip height of 200 metres and has been subject to Environmental Impact Assessment. An EIA Report has been produced to accompany the application for consent.

RES has also applied for a direction under Section 57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.

All representations should be received not later than **30**<sup>th</sup> **September 2022**, although Ministers may consider representations received after this date.

Any subsequent additional information which is submitted by the developer will be subject to further public notice in this manner, and representations to such information will be accepted as per this notice.

As a result of a statutory objection from the relevant planning authority, or where Scottish Ministers decide to exercise their discretion to do so, Scottish Ministers can also cause a Public Local Inquiry (PLI) to be held.

Following examination of the environmental information, Scottish Ministers will determine the application for consent in two ways:

- Consent the proposal, with or without conditions attached; or
- Reject the proposal
